I, Akarshika Goel, Partner of M/s. Grover Ahuja & Associates, Company Secretaries having its office at 302, Third Floor, Gagandeep Building, Rajendra Place, New Delhi - 110008, have been appointed as the Scrutinizer by the Board of Directors of THE HI-TECH GEARS LIMITED ("the Company") having its registered office situated at Plot No. 24, 25, 26, Sector-7, IMT Manesar, Gurugram, Haryana-122050, for conducting the Postal Ballot process of the Company in a fair and transparent manner in respect of the Resolution as proposed in the Postal Ballot Notice dated 25th March, 2025, for the purpose of scrutinizing the Postal Ballot by remote electronic voting process pursuant to the provisions of Section(s) 108 and 110 of the Companies Act, 2013 (the "Act") read with the Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014, as amended from time to time, the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations"), Secretarial Standard-2 ("SS-2") on "General Meetings" issued by the Institute of Company Secretaries of India and other applicable laws and regulations (including any statutory modification(s) or re-enactment(s) thereof, for the time being in force).

The Company is in compliance with the provisions of Section 110 of the Act read with Rule 20 and 22 of the Companies (Management & Administration) Rules, 2014, General Circulars No. 14/2020 dated 8th April, 2020, 17/2020 dated 13th April, 2020, 20/2020 dated 5th May, 2020, 22/2020 dated 15th June, 2020, 33/2020 dated 28th September, 2020, read with other relevant circulars including General Circular No. 09/2023 dated 25th September, 2023 and General Circular No. 09/2024 dated 19th September, 2024 issued by the Ministry of Corporate Affairs, Government of India ("MCA Circulars").

As permitted by MCA Circulars, the Company served the requisite notice pursuant to Section 110 of the Act along with draft of the Resolution and Explanatory Statement as required under Section 102 of the Act read with the SEBI LODR Regulations in electronic form only to the members of the Company, whose names appeared in the Register of Members /records of Depositories viz. Central Depository Services Limited (CDSL)/ National Securities Depository Limited (NSDL) as on Friday, March 21, 2025, as per the exemptions provided in the MCA circulars mentioned above.

Accordingly, in compliance with Section 108 of the Act read with Rules made thereunder and MCA Circulars and Regulation 44 of the SEBI LODR Regulations, the Company extended only Remote e-voting facility to its members to enable them to cast their votes electronically instead of postal ballot form. Hence, the communication of the assent or dissent of the Members had to take place through the Remote e-voting system only.

The Company had appointed NSDL as the Service Provider for extending the facility of Remote e-voting to the shareholders of the Company from Monday, March 31, 2025, at 09:00 A.M. (IST) and will end on Tuesday, April 29, 2025, at 05:00 P.M. (IST) (both days inclusive). The Remote e-voting was thereafter disabled by NSDL. The Remote e-
